### **Substance 215-168-2: Diirontrioxide, Fe<sub>2</sub>O<sub>3</sub>, Red Iron Oxides**

The substance is not classified as dangerous according to the criteria of the Dangerous Substances Directive (67/548/EEC). Specific Risk Management Measures are therefore not required (ECHA Chapter R12: PROC, AC and ERC can be discarded).

Nevertheless, the exposure of workers during and after normal operations should be minimized by the use of good industrial hygiene practice, the general measures necessary for safety and health protection of workers should be followed.
